The Waugh Family Foundation Book Prize in Canadian Business History

The **Canadian Business History Association (CBHA)** offers a tri-annual prize for the **Best Book in Canadian Business History** (broadly defined), as one of three prizes sponsored by the Waugh Family Foundation. The prize committee encourages the submission of books from all methodological perspectives. It is particularly interested in innovative studies that have the potential to expand the boundaries of the discipline. Scholars, publishers, and other interested parties may submit nominations. Eligible books can have either a Canadian or an international focus but should include a significant Canadian perspective or be written by a Canadian author. They must be written in English or French and be published during the two years prior to the award, that is **books published in 2023 and 2024 are eligible. The award includes a prize of \$10,000**, with the award announced later in 2025.

Four copies of a book must accompany a nomination and be submitted to the **CBHA/ACHA Prize Coordinator, Steven Bright, Executive Director of the CBHA, at 432 Ambleside Drive, Oakville, ON L6H 6N7. The deadline for nominations is February 28, 2025.** If you would like to submit any books for consideration, please do so by that date. Prix du livre de la Fondation de la famille Waugh en histoire des affaires canadiennes

L'**Association canadienne d'histoire des affaires (ACHA)** offre un prix biennuel pour le **Meilleur Livre en Histoire des Affaires au Canada** (au sens large), l'un des trois prix parrainés par la Fondation de la famille Waugh. Le comité du prix encourage la soumission de livres provenant de toutes les perspectives méthodologiques. Il s'intéresse particulièrement aux études innovantes qui ont le potentiel d'élargir les limites de la discipline. Étudiants, éditeurs et toutes autres personnes intéressé(e)s peuvent soumettre leur candidature. Les livres éligibles peuvent adopter soit un point de vue canadien, ou un point de vue international incluant une perspective canadienne. Ils doivent être écrits en anglais ou en français, et avoir été publiés au cours des deux années précédent la remise du prix, c'est-à-dire en 2023 et 2024. **Le prix inclut une récompense de 10 000 \$.**

Quatre exemplaires d'un livre doivent accompagner chaque soumission, qui doit être soumis au **Coordinateur de prix de l'ACHA/CHBA, Steven Bright, 432 Ambleside Drive, Oakville, ON L6H**. The 2025 CBHA/ACHA Award for Best Scholarly Article in Canadian Business History

The Canadian Business History Association (CBHA/ACHA), Canada's foremost organization promoting the study of business history, invites **applications for its annual \$1,000 Award for Best Scholarly Article in Canadian Business History**. The award recognizes outstanding contributions to the field and welcomes submissions employing any methodological approach. Articles published in academic journals or journalistic outlets are eligible, provided they demonstrate thorough research and analytical rigor. The committee is particularly interested in groundbreaking work that pushes the boundaries of the discipline. Nominations may be submitted by scholars, publishers, journalists, or other interested parties.

Eligible articles should either focus on Canadian topics or include a Canadian perspective within an international context. Submissions must be written in English or French and published within the year prior to the award.

To be considered, either the author or nominator must hold current membership in the CBHA/ACHA. For co-authored articles, at least one author must be a member. Articles published in 2024 are eligible for the 2025 award. The winner will receive a certificate, a \$1,000 prize, and formal recognition in the CBHA/ACHA Prospectus.

The award is traditionally announced during the Annual Meeting of the Canadian Historical Association in June but may be announced earlier.

The 2025 Desautels Research Fund in Private Enterprise, History & Law

The **Marcel A. Desautels Centre for Private Enterprise and the Law** offers support for a research project on private enterprise, law and history through the CBHA/ACHA. Applicants are encouraged to think creatively in developing proposals that will result in a scholarly article that takes an historical perspective on a Canadian family controlled or other private business, and considers its intersections or relationship with the law. The field of study is open to any time period, but projects should consider businesses operating in a domestic, Canadian context.

The successful applicant will receive up to \$1,000 to support the completion of the project. Academic support and oversight will be provided by an Academic Advisory Board drawn from the CBHA's membership. The Research Fellowship is open to PhD students and postgraduate scholars at an early stage of their academic careers (within five years of completing their degrees).

The deadline for applications to the Desautels Research Fellowship is **28 February, 2025**. Applicants should include a cover letter, detailed project proposal, and curriculum vitae to be sent to the CBHA Grants Coordinator, at cbha.acha@gmail.com
